**Release:**

I understand that the handling of animals and other volunteer activities on behalf of Dogstar may place me in a hazardous situation and could result in injury to my personal property or me. On behalf of myself, and my heirs, personal representatives and assigns, I hereby release, discharge, indemnify and hold harmless Dogstar Pet Boarding, LLC and its directors, officers, employees and agents from any and all claim, causes of actions and demands of any nature, whether known or unknown, arising out of or in connection with my volunteer activities on behalf of Dogstar.
